<b>INTEREST RATE GUARANTEE TERMS</b>	<ul style="list-style-type: none"> <li>• Interest rate for each guarantee period is set at issue and guaranteed for the duration selected</li> <li>• Premium must be held for the full interest rate guarantee period in order to receive the full amount of interest</li> <li>• At the end of the guarantee period, you have a 30-day window within which to select one of three options:                             <ol style="list-style-type: none"> <li>1. Surrender any amount of the contract free of charge</li> <li>2. Renew the contract for another guarantee period of the same duration, if available<sup>2</sup></li> <li>3. Renew the contract for a different interest rate guarantee period available at that time</li> </ol> </li> <li>• If you do not choose one of these options, the contract will renew automatically for the same guarantee period, or the nearest available term. (A reminder will be mailed.)</li> <li>• Interest rate credited for the new guarantee period will be based on the rates in place at that time and declared in advance</li> <li>• Interest rate for future guarantee periods will never be less than the minimum guaranteed interest rate of 1%</li> </ul>

## Features (continued)

<b>MARKET VALUE ADJUSTMENT (MVA)</b>	<ul style="list-style-type: none"><li>• The MVA is intended to reflect the change in the interest crediting rate from the start of the guarantee period to the time of surrender or withdrawal, as well as an adjustment for the time remaining in the guarantee period</li><li>• The MVA can be positive or negative. There is no limit on a positive MVA. A negative MVA may not cause the amount received upon surrender to be less than 87.5% of premium accumulated at 1%, reduced for net withdrawals</li></ul>
<b>ANNUITY PAYMENT OPTIONS</b>	<ul style="list-style-type: none"><li>• You can annuitize your contract after the first year with no penalty</li><li>• Seven fixed annuity payment options are available (see your contract or financial representative for details of each)</li></ul>
<b>DEATH BENEFIT</b>	<ul style="list-style-type: none"><li>• Payable on death of any owner</li><li>• Death benefit is equal to contract value (no surrender charges or MVA will apply)</li><li>• Death benefit proceeds are paid directly to named living beneficiaries and may not be subject to the probate process</li></ul>

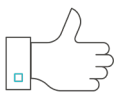
